Volunteer Release and Waiver

PLEASE READ CAREFULLY!

THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS!

This Release and Waiver of Liability (the "Release") is executed by _____ (the "Volunteer"), in favor of Nomads of Hope, Inc., a Massachusetts nonprofit corporation, its directors, officers, employees, and agents (Collectively "Nomads").

The Volunteer desires to participate with Nomads and to engage in the activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities may include but are not limited to: pre-trip activities, post-trip activities, various community service activities, basic home repair, home construction, educational activities, recreational activities and travel.

It is the policy of Nomads to provide Activities that are as safe as possible realizing that many of the activities have many inherent safety hazards.

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

Release and Waiver. Volunteer hereby releases and forever discharges and holds harmless Nomads and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Nomads. Volunteer understands that this Release discharges Nomads from any liability or claim that the Volunteer may have against Nomads with respect to any bodily injury, personal injury, illness, death or property damage that may result from Volunteer's Activities with Nomads, whether caused by the negligence of Nomads or its directors, officers, employees, agents or otherwise. Volunteer also understands that Nomads does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

Medical Treatment. Volunteer hereby releases and forever discharges Nomads from any claim whatsoever which arises or may hereafter arise on account of any first aid, medical treatment, or service rendered in connection with the Volunteer's Activities with Nomads.

Assumption of the Risk. The Volunteer understands that the Activities include work that may be hazardous to the Volunteer. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities and releases Nomads from all liability for injury, illness, death or property damage resulting from the Activities.

Insurance. Nomads require the Volunteer to provide proof of medical insurance. Nomads does not provide medical insurance to Volunteers.

Photographic Release. Volunteer grants and conveys unto Nomads all right, title, and interest in any and all photographic images and video or audio recordings made by Nomads during the Volunteer's Activities with Nomads, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other. Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Massachusetts. This Release shall be governed by and interpreted in accordance with the laws of the State of Massachusetts. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provision of this Release which shall continue to be enforceable.
